**SECTION 4. FUNCTIONS OF BDC EXECUTIVE COMMITTEE**-The BDC Executive Committee shall have the following functions:

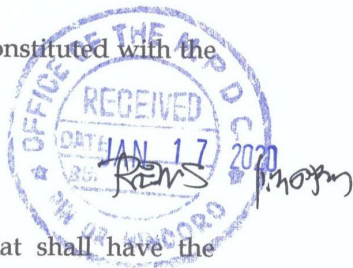
1. Ensure that the decision of the council are faithfully carried-out and implemented;

**SECTION 4. FUNCTIONS OF BDC SECRETARIAT-**The BDC Secretariat shall have the following functions:

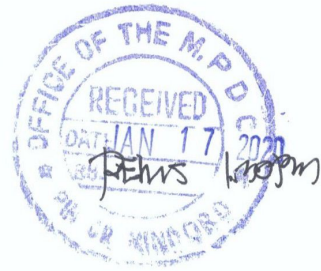
- 1. Provide technical support of the BDC;
